Challenges to Transaction Monitoring

Organizations face various challenges when establishing effective transaction monitoring. Therefore, staying up-to-date is crucial as monitoring laws, regulations and expectations are complex and change frequently. Furthermore, businesses should avoid siloed infrastructures which may lead to duplications of work, and which can result in poor data quality overall – whereas high data quality allows for transparency in data sources. Additionally, labour intensive processes, a lack of data integration, proper system calibration, and automation can result in significant false positives. This requires investigators to gather data from multiple sources and duplicate it in their case management tool. However, these manual investigative processes absorb too many resources and add unnecessary complexity to their workflow.
